- Maintenance of the gate is the responsibility of the landowner.
- As the gate donor, I am responsible for the maintenance of the plaque. (FOTNP will replace plaques if required. The cost of replacement plaques will be borne by the donor.)
- The type of gate to be installed will be the most suitable for the location as determined by the relevant local authority rights of way officer in conjunction with the landowner.
- Gate locations will be determined/agreed by the relevant local authority rights of way officer.
- FOTNP are unable to agree specific locations. However any request for a specific location within the North Pennines will be passed to the relevant rights of way officer.
- Gates will be installed as soon as possible as determined by any necessary permissions and the nature, quantity and location of all work to be carried out. Therefore a time limit cannot be guaranteed for the installation.
- FOTNP will contact the donor to confirm the installation has been completed and the location of the gate.
- FOTNP will be the sole arbiter if a memorial inscription is considered unsuitable.
